3. Request to hold a public local inquiry under regulation 17 (1) of the Water Abstraction and Impoundment (Licensing) Regulations (Northern Ireland) 2006.

Applicant: Dalradian Gold.

NIEA Reference: AlL-2020-0105.

Location: Curraghinalt Mine, Teebane West, near Greencastle, County Tyrone.

Proposal: The abstraction and impoundment of surface water associated with a

4. Request to hold a public local inquiry under regulation 17 (1) of the Water Abstraction and Impoundment (Licensing) Regulations (Northern Ireland) 2006.

In reference to these four applications received for environmental authorisation (NIEA References: TrC 080/20_1, TrC 081/20_1, AlL-2020-0105 and AlL-2020-0106), the Department requires that for the purposes of considering representations received in

respect of these applications, a public local inquiry shall be held by the Appeals Commission (the 'Commission) in accordance with the provisions of Schedule 1. 3(4) of the Water (Northern Ireland) Order 1999 and regulation 17 (1) of the Water Abstraction and Impoundment (Licensing) Regulations (Northern Ireland) 2006.

I am aware that the Department for Infrastructure (Dfl) wrote to the Commission on 22 September 2021 to request the Commission hold a public local inquiry into planning application LA10/2017/1249/F, and related applications associated with the Dalradian Gold mine proposals.
