Dear Water Regulation Team

At the pre-inquiry meeting on 20th March 2024, the Commission requested various pieces of information relating to procedural matters. The Commission subsequently published a list of action points on its website on 22nd March 2024.

I confirm receipt of your correspondence dated 29th and 30th March 2024, which addresses action points 1, 2, 3, 5 and 6 of the Commission's action point list.

However, it has been noted that only some of the information requested has been submitted to address action point 4. The Commission has not received the following:

1. Any documentation clarifying any extensions of time agreed for the water abstraction and impoundment licence applications.
2. Extension letter one and three for water consent discharge application TrC 081/20_1 and extension letter three for application TrC 080/20_1.

The Department agreed at the meeting that that this information would be provided. Failure to do so within the timelines as agreed is unacceptable. It is imperative that this correspondence is provided to the Commission forthwith.

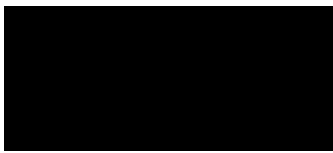
