Questions

- 1. Proposed Change 09 (PC09) seeks to change the heading of Table 6 on page 52 of the dPS to 'Overall Growth Strategy for District as Proposed at LDP POP Stage'. However, Paragraph 5.4 of the POP states that the Council's Preferred Option 2 would have planned growth of +7-12k homes as opposed to +8-10k stated in Table 6. Would this proposed change avoid misunderstanding?
- 2. Should the dPS's Growth Strategy be based on 'planned growth' (Table 6, page 52 of the dPS) as opposed to 'potential growth'? Is this required to align with other Council growth strategy documents as claimed by representors?
- 3. Will the proposed provision of 9k new homes support the ambition to deliver 15k more jobs and the projected population growth of approximately 10k people?
- 4. Will it be possible to provide the approximate 4-5k new social housing homes whilst supporting the creation of sustainable and mixed communities?

- 2. Is it appropriate for Proposed Change 174 (PC 174), which relates to Paragraph 20.8 of the dPS, to make specific reference to Document EVB 20 listing the existing waste management sites? Would this information continue to be available for reference should the plan be adopted?

- 1. Does the identification of Ebrington as a Special Economic Development Area (SEDA) within the dPS constrain its future development and could it limit the site's ability to accommodate certain proposals?
- 2. The dPS (page 116) states that there is sufficient economic land in terms of quantity and that the General Development Areas (GEDAs) provide different types of existing economic areas throughout the District, with there being no strategic need to expand GEDAs through the LDP. Has consideration been given to the individual site assessments? Does the uptake of zoned land within DAP 2011 demonstrate a lack of market interest in the zoned lands?
- 3. Numerous concerns have been raised by the community in relation to industrial land adjacent to Strathfoyle. Is this the 48.9ha of industrial land at Maydown identified in Document DS-213 EVB 9-Economic Development Land Evaluation Report December 2019 and will it be re-assessed at the LPP stage for other purposes?
- 4. Does Policy ED 2 Office Development take account of Policy PED 1 in terms of Class B1(b) use?
- 5. Does Policy ED 3 Economic Development in Settlements take account of Policy PED 1 in terms of Class B2 and B3 uses?
- 6. Given the claimed oversupply of economic development land in the plan area, is Policy ED 4 sufficiently flexible in terms of alternative proposals? In terms of unzoned land in settlements, has account been taken of Paragraph 6.89 of the SPPS?
- 7. Whilst Paragraph 7.27 of the PS states that at the local policies plan stage the type and range of economic development that will be acceptable within specific zoned sites and other key strategic sites and locations will be specified, does Version 2

- Policy ED 4 Protection of Zoned and Established Economic Development Land and Uses take account of PPS 4 Policy PED 7 Retention of Zoned Land and Economic Development Uses in terms of sui generis employment use?
- 8. Is it clear what the policy criteria would be for assessing the small scale complementary/ancillary use referred to in Policy ED4(h) and paragraphs 9.29 and 9.30 of the Justification and Amplification text?

Designation HC 1: Proposed Hierarchy of Centres

- 1. Paragraph 6.277 of the SPPS states that the LDP should define a network and hierarchy of centres-town, district and local centres, acknowledging the role and function of rural centres. Given that there is no District Centre identified outside Derry, has the Council taken account of Paragraph 6.277 of the SPPS and should the Kennedy Centre in Strabane be identified as a District Centre? Is the Kennedy Centre distinguishable from Springtown in Derry?
- 2. Document DS-214 (paragraph 6.12) states that principally due to existing commitments at Artnz and Springtown in Derry and the Three Rivers in Strabane that it is anticipated that there is no capacity for convenience floorspace over the entire plan period up to 2032. What is the planning status of the Three Rivers project in Strabane? Have the Springtown planning permissions expired?

- 3. Does Paragraph 10.15 of the dPS go beyond the scope of the SPPS?
- 4. Does Policy RP 1 take account of the SPPS in terms of its advocated sequential approach? Whilst not perhaps the Council's intention, does it and Proposed Change 55 (PC 55) appear to consider district and local centres on the same tier as town centres?
- 5. Should the sequential approach be applied to district and local centres?

Does this take account of Paragraphs 6.150 and 6.151 of the SPPS which state that such proposals can have significant and irreversible adverse impacts on the environment?
- 2. Proposed changes 105 and 107 (PC 105 and PC 107) proposed to remove the reference to sites proposed for declaration and designation. Does this take account of Paragraph 6.158 of the SPPS? Would this proposed deletion contradict proposed change 178 (PC 178)?
- 3. Document DS-500 Public Consultation Report (March 2022, page 98) states that the Council will prepare a SPG with guidance on the implementation and requirements of restoration bonds. At what stage in the process is it anticipated that such guidance will be produced?
