I refer to your correspondence letter of 5<sup>th</sup> October 2021 and subsequent email communication and would like to provide a formal response from NIEA following internal discussion.

In the letter of 5<sup>th</sup> October 2021 NIEA were contacted by WSP who wished to seek advice and input to the design and implementation of a habitat management plan at McKean's Moss ASSI. This is in relation to the proposed A5 Western Transport Corridor following recommendations made in the Planning Appeals Commission (PAC) report resulting from the 2020 Public Inquiry for the proposed scheme.

I can advise you that McKean's Moss ASSI has not been received a condition assessment since 2009. The consensus from our meeting is that without contemporary site survey information it will not be possible to be able to provide authoritative input into a habitat management plan.

We would therefore recommend that a rapid condition assessment should be undertaken to provide baseline information about the site which will help inform NIEA input into future advice on a habitat management plan for the site.
