Apologies for the late reply to your e-mail.

I am perhaps not the correct contact for you but I am trying to see where it may fit within NED. My role is primarily Team Lead for permissions for activities within designated sites and providing advice to planning consultations; we have a separate Habitat Survey Team and they may need to advise on this proposal and a separate team within CDP known as Management of Sensitive Sites team (MOSS), who previously had a management agreement with the landowners to manage grazing and carry out scrub removal on the ASSI, which ended in 2017.

The ASSI itself, you should be aware, is in favourable condition from our last assessment, and I had a preliminary chat internally and the suggestion is there may be minimal works required, however, it depends on what you would like to do. I will try and get the latest condition assessment reports for you to consider the NED assessment of the site.
