Further to your application of 27 March 2013, please find attached an Excavation Licence for the above-mentioned location.


Please note that under the terms of the Licence you must, on completion of the excavation, furnish:

***Historic Monuments and Archaeological Objects (Northern Ireland) Order 1995***

**LICENCE TO EXCAVATE FOR ARCHAEOLOGICAL PURPOSES**

The Department of the Environment for Northern Ireland (hereinafter referred to as "the Department"), in exercise of its power under Section 41 of the above-mentioned Order, hereby licenses Matt Nichol (hereinafter referred to as "the Licensee") to dig or excavate for purposes of archaeological evaluation in or under part of the Townland (town) of Sollus in the County of Tyrone (being the archaeological site or reputed site known as A5 Road Scheme - Section 1) during the period of six months, commencing on **29 March 2013 and ceasing on 28 September 2013**, subject to the following conditions:-

1. The Licensee shall, before commencement of any work on the site, produce this Licence to the Officer in Charge of the nearest Police Station<sup>1</sup>, and shall, if so requested, also produce the Licence to the owner or occupier of the lands on, in or under which the work will be carried out.
2. The Department reserves the right to suspend or revoke this Licence at any time in the event of failure by the Licensee to comply with these conditions.
3. In advance of commencement of works, the licensee must inform the Department of the start date of the excavation, name of the licensee / director, licence number, contact phone number for the licensee / director, reason for excavation, and likely duration.
4. The Licensee shall, during the progress of the works, take adequate steps to safeguard any monuments or other structures upon or adjoining the site.
5. The Licensee, if not an official of the Department, shall permit any person or persons nominated by the Department to be present at any stage of the work.

<sup>1</sup> Other arrangements may be made, providing they are acceptable to the Department

6. The Licensee shall report the finding of any archaeological object in accordance with Section 42 of the above-mentioned Order and shall in all other respects comply with the said Section 42.
7. The Licensee shall, before expiry of the Licence, restore the site and its surroundings as far as possible to their original condition unless the Department otherwise directs and the Department shall have the right to recover from the Licensee, if the latter is not an Official of the Department, the cost of any work which it may undertake by reason of the failure of the Licensee to restore the site.
8. The Licensee shall furnish to the Department, within four weeks from the completion or temporary cessation of the excavation, a short report stating its main archaeological results. On final completion of the excavation the Licensee shall prepare and submit to the Department within a period of six months a full report illustrated with drawings and photographs suitable for lodgement in the Northern Ireland Monuments and Buildings Record, 5-33 Hill Street, Belfast BT1 2LA.
9. This Licence is granted on condition that, except in the case of an excavation referred to in Section 32 (1) (b) of the Historic Monuments and Archaeological Objects (NI) Order 1995, the Licensee has obtained or will obtain from the owner or occupier of the lands their consent to the digging or excavation on, in or under the said lands, and the Department, if the Licensee is not an Official of the Department, shall not be under any responsibility for the consequences of any failure on the part of the Licensee to obtain such consent.
10. Should any part of the excavation involve disturbance of an area designated as a scheduled site, the Licensee must ensure that Scheduled Monument Consent has been obtained from the Department before any such work is undertaken.
